



IV. Report from the Dean of the Graduate School

Dr. Mary Anne Templeton reminded the council of the research showcase for each college which will be next semester, and any curriculum changes that will need to be approved by the Graduate Council needs to be worked on now.

College of Arts and Sciences

1. Student #1— Extension of Eight-Year Requirement (MSIR)

Master of Science in International Relations student requesting an extension and has a (3.33 GPA). Dr. Harrington presented the student's request for an extension of the eight-year waiver. Dr. Harrington advised that the College of Arts and Sciences academic review committee had reviewed the request and recommended approval of the extension until Term 4, 2016. Following a brief discussion, Dr. Harrington motioned to approve the recommendation. Dr. Lynn Boyd seconded. The

motion was approved.

2. Student #2 — Extension of Eight-Year Requirement (MSIR)

Master of Science in International Relations student requesting an extension and has a (3.33 GPA). Dr. Harrington presented the student's request for an extension of the eight-year waiver. Dr. Harrington advised that the College of Arts and Sciences academic review committee had reviewed the request and recommended approval of the extension until Term 3, 2017. Following a brief discussion, Dr. Harrington motioned to approve the recommendation. Dr. Steve Grice seconded. The motion was approved.

3. Student #3— Extension of Eight-Year Requirement (MPA)

Master of Public Administration student requesting an extension and has a (3.33 GPA). Dr. Vicky Edwards presented the student's request for an extension of the eight-year waiver. Dr. Edwards advised that the College of Arts and Sciences academic review committee had reviewed the request and recommended approval of the extension until Term 5, 2016. Following a brief discussion, The Graduate Council agreed to allow the student an Extension, and that they are moved into the 2015-2016 Graduate Catalog. Dr. Spurlock motioned to approve the recommendation. Dr. Grice seconded. The motion was approved.

College of Education

4. Student #4 — Extension of Eight-Year Requirement (MCPSC)

Master of Science in Education: School Counseling student requesting an extension and has a (3.92 GPA). Dr. Boyd presented the student's request for an extension of the eight-year waiver. Dr. Boyd advised that the College of Education academic review committee had reviewed the request and recommended approval of the extension until Term 4, 2017. Following a brief discussion, Dr. Spurlock motioned to approve the recommendation. Dr. Bridgette Colaco seconded. The motion was approved.

5. Student #5 — Extension of Eight-Year Requirement (MCPRHB)

Master of Science in Counseling and Psychology: Rehab Counseling student requesting an extension and has a (3.46 GPA). Dr. Boyd presented the student's request for an extension of the eight-year waiver. Dr. Boyd advised that the College of Education academic review committee had reviewed the request and recommend approval of the extension until December 2016. Following a brief discussion, Dr. Spurlock motioned to approve the recommendation. Dr. Boyd seconded. The motion was approved.

College of Health and Human Services

6. Graduate Catalog Corrections to MSN Certificates and DNP Admission Criteria

Dr. Amy Spurlock presented the proposal for catalog corrections. First, being the front table for the degrees offered in the College of Health and Human Services, as MSN Certificates are available at four Troy locations and not Etroy. Second, corrections are made for the DNP admission criteria so that both current accreditations are listed, instead of just one. Following a brief discussion, Dr. Grice motioned to approve the recommendation. Dr. Boyd seconded. The motion was approved.

Sorrell College of Business**7. Student #6— Extension of Eight-Year Requirement (MBA)**

Master of Business Administration student requesting an extension and has a (2.50 GPA). Dr. Robert Wheatley presented the student's request for an extension of the eight-year waiver. Dr. Wheatley advised that the Sorrell College of Business academic review committee had reviewed the request and denied the extension. Following a brief discussion, Dr. Spurlock motioned to approve the recommendation. Dr. Colaco seconded. The motion was approved.

8. Student #7 — Extension of Eight-Year Requirement (MBA.IS)

Master of Business Administration: Information Systems student requesting an extension and has a (3.57 GPA). Dr. Wheatley presented the student's request for an extension of the eight-year waiver. Dr. Wheatley advised that the Sorrell College of Business academic review committee had reviewed the request and recommend approval of the extension until Term 5, 2016. Following a brief discussion, Dr. Grice motioned to approve the recommendation. Dr. Colaco seconded. The motion was approved.

9. Student #8 — Extension of Eight-Year Requirement (MSHRM)

Master of Science in Human Resource Management student requesting an extension and has a (2.818 GPA). Dr. Wheatley presented the student's request for an extension of the eight-year waiver. Dr. Wheatley advised that the Sorrell College of Business academic review committee had reviewed the request and recommend approval of the extension until May 2016. Dr. Robert Wheatley advised that the Sorrell College of Business academic review committee had reviewed the request and denied the extension. Following a brief discussion, The Graduate Council agreed to allow the student an extension of four courses until Term 4, 2017. Dr. Colaco motioned to approve the recommendation. Dr. Grice seconded. The motion was approved.

11. Student #10 — Extension of Eight-Year Requirement (MSHRM)

Master of Science in Counseling and Psychology: Rehab Counseling student requesting an extension and has a (2.9 GPA). Dr. Wheatley presented the student's request for an extension of the eight-year waiver. Dr. Wheatley advised that the Sorrell College of Business academic review committee had reviewed the request and denied the extension. Following a brief discussion, The Graduate Council agreed to allow the student an extension of their 2007 courses until Term 2, 2016. Dr. Spurlock motioned to approve the recommendation. Dr. Grice seconded. The motion was approved.

12. Student #11 — Extension of Eight-Year Requirement (MSM.IS)

Master of Science in Management: Information Systems student requesting an extension and has a (3.00 GPA). Dr. Wheatley presented the student's request for an extension of the eight-year waiver. Following a brief discussion, The Graduate Council agreed to allow the student an extension until Term 5, 2016. Dr. Diane Bandow motioned to approve the recommendation. Dr. Colaco seconded.
