- 1.) THE MEETING WAS CALLED TO ORDER: Dr. Dew called the meeting to order and asked that everyone introduced themselves.
- 2.) Briefing on Approvals for the University (Donna Sanders)
 - a. SACSCOC– We are still waiting to hear on:
 - i. Master of Arts in Economics
 - ii. Master of Science in Second Language Instruction
 - iii. Hurlburt Field site close-out & teach-out
 - b. Approval
 - i. Master of Taxation and Chemistry Program teach-out
 - ii. Bachelor of Science in English being taught via e-Troy
 - c. Partnership agreement
 - i. Samford and Jones Laws (These need to be mailed out)
 - d. Catalog changes that need to be made for Fall 2015.
- 3.) Dr. Dew made some comments about Homer Reports:
 - a. Dr. Dew stated that he had read all of the College of Arts and Sciences reports. The level of 2011-2013 reports compared to the 2009-2011 reports is remarkable, and they are really well done. I know, we have one department that has some issues. College of Health and Human Services has always been outstanding with their reports and their latest reports look outstanding as well. The report from College of Communication and Fine Arts was impressive as well. Dr. Dew has asked Wendy to follow up on some viability data for some of the programs that would say to the reviewers were real programs. We have a few specialty programs that only have two people graduating per year; but we have more in the program. We look forward to hearing from the Sorrell College of Business and College of Education.
