

**Approved Minutes of the Faculty Senate Meeting
June 22, 2016**

Meeting called to order at 2:00 PM by President Dionne Rosser-Mims.

Reports Committees

I. Executive Committee: Dr. Rosser-Mims

- a. As the outgoing president, Dr. Dionne Rosser-Mims welcomed all newly elected and reelected senators present at the meeting. She emphasized that although she had no official report, she wanted to share her reflections on the work and accomplishments of the Senate during her two-year tenure. Prior to this, Dr. Rosser-Mims stressed that the Executive Committee met last week and had a good bit of discussion regarding two resolutions: Resolution 3-2015-2016 (Faculty Handbook Change – Professor Emeritus) and Resolution 4-2015-2016 (Faculty Handbook Change – CRC Composition). She was very pleased with the level of discussion on the topic. *(Both resolutions were passed by the Faculty Senate at 6/22/2016 meeting – see below).*
- b. Dr. Rosser-Mims' reflections on the work and the accomplishments of the Senate during 2014-2015 and 2015-2016 academic years:
 - i. Dr. Rosser-Mims emphasized that two academic years constitute a very good period to set goals and to accomplish goals that were set during her convocation speech back in the fall of 2015.
 - ii. Prior to reflecting on such goals, Dr. Rosser-Mims took the time to thank, and in fact expressed big thanks, to the Senate Leadership: Dr. Lane Eckis and Dr. Margaret Gnoinska, and the chairs of the Standing Committees: Dr. Vijaya Gomba, Dr. Trellys Riley and Dr. Zhiyong Wang, as well as the rest of the Senate membership. She emphasized that lots of meaningful discussion took place on the issues that the Senate worked on in the past two years.
 - iii. Dr. Rosser-Mims reflected on the four major goals for the Faculty Senate that she set in 2015 as the new president. These goals included: 1) the strengthening of shared governance at the University; 2) the introduction of bold and innovative ideas; 3) the introduction of digital solutions to improve the workflow; and 4) the strengthening of communication at the University. She stressed

that the reflections provided below included only highlights and certainly not every detailed activity and the overall hard work of the Faculty Senate. The items that Dr. Rosser-Mims selected as to be particularly proud of are as follows:

1. We invited key administrators to our Faculty Senate meetings to help resolve miscommunication and any confusion. In other words, we made sure that we wanted the faculty to hear from the horse's mouth regarding new policies and changes that were taking place at the University. The faculty had the opportunity to ask questions and engage in a discussion.
2. We administered the Faculty Survey. The discussion around the idea of conducting a faculty survey was initiated by Dr. Maureen Casile. This process began prior to my leadership as the Faculty Senate president. What we did under the leadership of Dr. Vijaya Gompa was to take the idea and devise such a survey. As far as I know, this is the first time that such a survey has ever been devised at Troy University with a purpose of getting feedback from the faculty. The work that the Faculty Senate has done has been tremendous in this area and I thank the senators involved in the process. We have institutionalized two surveys: one to be conducted every year and one to be conducted every two years based on Resolution 1a -2015-2016 and 2a – 2015-2016 (please refer to the Faculty Senate website to view the resolutions at <http://trojan.troy.edu/employees/standingcommittees/resolutions/FS/1a-Resolution-201-2015-2016.pdf> and <http://trojan.troy.edu/employees/standingcommittees/resolutions/FS/2a-Resolution-2015-2016.pdf>)
3. Other accomplishments include the efforts of Dr. Riley and Dr. Wang to initiate and to elevate the conversation to go digital. We have made much progress to go paperless wherever possible to facilitate the workflow. I would like to thank and commend Dr. Greg Price from the Information Technology for his constant support and assistance in this area.
4. The accomplishments also include the Faculty Senate initiated Annual Troy University Student Appreciation Day. I would like to express my thanks especially to Dr. Lane Eckis here for her tireless work in making this endeavor successful two years in a row. And, thank you all, who participated in making the event a great success. We truly served as a connector between students and faculty and the administration.
5. Finally, thank you all for the hard work you have done

during the academic years of 2014-2015 and 2015-2016.

II. Committee on Committees: Dr. Boyte-Eckis

I have served as the Vice President of the Faculty Senate for the past two years. The two years have been very successful in my opinion. Thank you all for your great work.

III. Elections Committee: Dr. Gnoinska
