IV. For Consideration by the Council

A. College of Arts and Sciences

1. Proposed change in the Army ROTC Military Science minor

By unanimous vote, the Council approved adding three semester hours to the Military Science Minor, bringing the total number of required hours to 19. The Military Science Minor course requirements will read as the following in Troy University's 2007-2008 Undergraduate Catalog:

B. College of Health and Human Services

1. Proposed changes in the course descriptions for NSG 4430 and NSG 4431 in the RN to BSN/MSN track of the BSN program.

By unanimous vote, the Council approved a new course description for NSG 4430 Advanced Nursing Theory (3). The following description will be included in the 2007-2008 Troy University Undergraduate Catalog:

“Examines individual and group responses to complex, multi-system stressors within the human-environment interactive system. Emphasizes the nurse’s role in diagnosing and treating individual and groups with complex, multi-system stressors through the use of nursing concepts in various health care settings. The role of the nurse as a leader and manager is also examined. *Prerequisites: Successful completion of all general studies courses, NSG 3370, NSG 3309, NSG 3310, NSG 4405, NSG 4406, and NSG 4407. Co-requisite: NSG 4431.*”

By unanimous vote, the Council approved a new course description for NSG 4431 Advanced Nursing Preceptorships (2-6). The following description will be included in the 2007-2008 Troy University Undergraduate Catalog:

“Provides clinical learning opportunities for students to examine individual and group responses to complex, multi-system disease processes as well as leadership and management skills. Emphasizes the nurse’s role in diagnosing and treating individuals and groups with complex, multi-system disease processes through the use of nursing concepts. Emphasizes the role of the nurse as a leader and manager. *Prerequisites: Successful completion of all general studies courses, NSG 3370, NSG 3309, NSG 3310, NSG 4405, NSG 4406, and NSG 4407. Co-requisite: NSG 4430.*”
